TRAINING OBJECTIVE

Upon completion of this session, participants will have a foundational understanding of sex trafficking laws and investigations, recognize signs of sex trafficking, learn strategic tools to engage in initial conversation with potential victims of sex trafficking, and know how sex trafficking is reported and what their role is in the process.

PERFORMANCE OBJECTIVES

- Define sex trafficking in legal and laymen's terms
- Describe differences in the way the law defines sex trafficking of adults versus minors
- Describe how the elements of force, fraud, and coercion apply to sex trafficking laws and investigations
- Recognize the signs of sex trafficking by understanding how traffickers operate
- Understand who promotes and drives the sex trafficking business
- Learn about sex buyers and what they are seeking
- Describe how traffickers connect sex trafficking victims with sex buyers
- Understand how the money ties into the buying process and why it is the motivating factor
- Identify those who are most vulnerable as potential targets of sex trafficking
- Identify the signs of sex trafficking through a sex trafficking case study
- Know who will come into contact with potential sex trafficking victims (i.e. those in the medical and social services field) and how to generate investigations
- Describe how to safely gather more information from a potential trafficking victim and the balance between the investigation and the well-being of the victim
- Identify resources available to assist trafficking victims
- Know how to report suspected sex trafficking
